For Baton Products

Safariland, LLC (the “Company”) warrants its Monadnock baton products to be free from defects in materials and workmanship under normal use for as long as the original purchaser owns the product. If you believe this product has any defects in materials or workmanship, cease use immediately and contact customer service for a remedy. If a product proves to be defective in materials or workmanship, at the discretion of Safariland we will repair or replace the product free of charge and send it to you at our expense. This warranty covers replacement against breaking, bending, rust, torn grip and broken retention spring under normal field use.

This LIMITED LIFETIME WARRANTY is the sole and exclusive warranty of this product by the Company and applies only where the product has been properly maintained in accordance with Monadnock instructions, and has not been subject to misuse, negligence or accident as solely determined by Safariland.

Misuse, whether intentional, negligent, accidental or otherwise, voids the guarantee as well as the limited lifetime warranty as provided herein. Any baton damaged by misuse or due to failure to follow instructions may be repaired at a reasonable charge to be solely determined by Safariland if the product is properly returned (postage prepaid) to Safariland.

All returns must have an RA# number to be processed. We unable to accept any return unless an RA# is included on the outside of the box.
